PRIVACY POLICY

CCMNT Speakers, LLC ("Company" or "we") is committed to protecting your privacy. This Privacy Policy details the steps we take to protect your personal information when you visit our website and applications that contain a link to this Privacy Policy or when you contact the Company.

1. COLLECTION OF INFORMATION

When you visit our site, we may ask you for personal information to provide a service or carry out a transaction that you have requested. You may also provide personal information to us when you contact us (e.g., with a comment, inquiry or customer support request). The personal information we collect from you when you use our Sites may include:

Identity data, such as your name, title, company/organization name, e-mail address, telephone and fax numbers and physical address (including street, city, state, postal code, and/or country);

Recruitment data, including information submitted in connection with an inquiry;

Marketing and communications data, including your marketing preferences;

Transaction data, including inquiries about and orders for our services;

When you do not provide requested information, we may not be able to provide you the requested service.

We collect certain information about your visit to our site, including:

Usage data, including information about how you use our site, what pages you view, the number of bytes transferred, the links you click, the materials you access, the date and time you access the site, the website from which you linked to our site and other actions taken within the site; and

Technical data, such as your Internet Protocol (IP) address, your browser type and capabilities and language and your operating system.

2. USE OF INFORMATION

We may use the personal information collected via our site or when you contact us for purposes that include:

Services and transactions. We may use your personal information to deliver services to you or carry out transactions you have requested, including, but not limited to, providing information on Company products or services you use, answering customer service requests and facilitating the use of our site.

Administering and protecting our business and site. We may use your personal information to administer and protect our business and our site, including troubleshooting, system maintenance, support, reporting and hosting of data.

Improving our business, site, and services. We may use your personal information to perform business analyses or for other purposes that help us to develop and improve the quality of our business, site and services (including new products and services), for example, by customizing our site to your particular preferences or interests.

Marketing. In accordance with applicable laws and regulations, we may use your personal information to inform you of products or services which may be of interest to you, and to otherwise communicate with you about offerings, events and news, surveys, special offers, and related topics. You are able to opt-out from marketing communications sent via e-mail at any time, free of charge by using the "unsubscribe" link in any e-mail marketing materials you receive from us, or by contacting us using the contact information listed in this Privacy Statement. Depending on your country of residence, you may also be able to opt out of other types of marketing communications; please contact us using the contact information listed in the Privacy Statement for more information.

Research and analysis. We may use your personal information to conduct research and analysis to help us analyze your preferences, identify the products and services that best meet your requirements and measure the effectiveness of the advertising we serve you.

Enforcement: We may use the personal information we collect in order to detect, prevent and respond to fraud, intellectual property infringement, violations of our terms and conditions, violations of law or other misuse of our site.

Where permitted by law, we may combine the information that we collect via our site with other information we hold about you (such as information about your use of our services) in order to offer you an improved and consistent customer experience when interacting with us or for other purposes set forth in this Privacy Statement.

3. BASES FOR PROCESSING INFORMATION

Where required by law, we will ensure there is a legal basis for the processing of your personal information. In most cases the legal basis will be that:

the processing is necessary for the performance our obligations to you or the provision of services we provide to you;

the processing is necessary to comply with our legal obligations, including compliance with applicable laws, regulations, governmental and quasi-governmental requests, court orders or subpoenas;

the processing is based on your consent to the processing of your personal information for one or more specified purposes (e.g., marketing); or

the processing is necessary to meet our legitimate interests, for example to develop and improve our sites, products and/or services for the benefit of our business partners.

4. DURATION FOR WHICH INFORMATION IS STORED

The period during which we store your personal information varies depending on the purpose for the processing. For example, we store personal information needed to provide you with products and services, or to facilitate transactions you have requested, so long as you are a business partner of the company. We store your personal information for marketing purposes until you have opted out of receiving further direct marketing communications. In all other cases, we store your personal information for as long as is needed to fulfill the purposes outlined in this Privacy Policy.

5. DISCLOSURE OF INFORMATION

We may share your personal information with selected third parties in accordance with applicable law, including as set out below.

CCMNT Speakers, LLC. We may share your personal information within the Company as reasonably necessary for the purposes set out in this Privacy Policy.

Service providers. We may share your personal information with companies with which the Company has contracted to provide services on our behalf, such as hosting websites, conducting marketing activities and surveys, processing transactions, analyzing our sites and performing analyses to improve the quality of our business, sites, products and services. We require these service providers to protect the confidentiality of your personal information.

Business partners. We may share your personal information with third parties that distribute our products and other business partners for purposes of providing products and services to you, and for marketing purposes.

Transactional disclosures. In connection with transactions, we may disclose your personal information to financial institutions, government entities and shipping companies or postal services involved in fulfillment of the transaction.

Disclosure for other reasons. We may disclose personal information if required or authorized to do so by law or in the good-faith belief that such action is necessary to comply with legal requirements or with legal process served on us, to protect and defend our rights or property or, in urgent circumstances, to protect the personal safety of any individual.

6. SECURITY

We are committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use or disclosure, including implementation of such security measures as may be required by applicable law. No information system, however, is completely secure, so we cannot guarantee the absolute security of your personal information. Additionally, we are not responsible for the security of information you transmit to the Company's site over networks that we do not control.

7. COOKIES

Cookies are text files containing small amounts of information that are downloaded to your computer when you visit our site. Cookies are useful because they help arrange the content and layout of our site and allow us to recognize those computers or other devices that have been to our site previously. Cookies allow our site to remember your preference settings and helping us to enhance the usability and performance of our site and your experience using our site.

Our site also may contain electronic images known as web beacons – sometimes called single-pixel gifs – that allow us to count the number of users who have visited specific pages. We may also include web beacons in promotional email messages or newsletters in order to determine whether messages have been opened and acted upon.

You can usually modify your browser settings to decline cookies and you can withdraw your consent at any time by modifying the settings of your browser to reject or disable cookies or by opting out of specific cookies through the opt-out options shared below. If you choose to decline cookies altogether, you may not be able to fully experience the features of the site.

8. ANALYTICS

We use industry standard web analytics to track visits to our site ("Analytics Providers"). The information generated by the cookie about your use of our site (including your IP address) will be transmitted to and stored by our Analytic Providers on their servers. Analytics Providers may use this information for the purpose of evaluating your use of our site, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Web Analytics Providers may also transfer this information to third parties where third parties process the information on their behalf.

9. YOUR RIGHTS

You may have certain rights with respect to personal information about you that is collected through the Company site or when you contact the Company. If you are located in the EEA, the rights described below may apply to you. For other users, the rights that apply to you will depend on the laws of your country of location. We will facilitate your exercise of the rights that apply to you. Access. You may have the right to access, review and correct personal information collected through our site or when you contact the Company. In some cases, you can do this by going to the page on which you provided the information.

Consent. We will respond to any requests from you to exercise your rights within the timeframes required by law. We may charge a fee to facilitate your request where permitted by law. To exercise any of your rights, please contact us using the contact details set out at the end of this Privacy Policy. We may take steps to verify your identity before acting on a request. If you believe our processing of your personal information does not comply with data protection law, you can make a complaint to the supervisory authority in charge of overseeing compliance with data protection law in your jurisdiction. We, however, would appreciate the opportunity to address your concerns, so please feel free to contact us regarding any complaint you may have.

10. CHILDREN'S INFORMATION

We do not knowingly collect information from children and do not target or direct our site to children.
